AGREEMENT FOR WEDDING PHOTOGRAPHY

Wedding Photography Agreement dated _____

OF THE SECOND PART

WHEREAS Photographer is in the business of providing professional photographic service and products ("Coverage"),

AND Client is desirous of engaging Photographer to provide such Coverage; NOW THEREFORE for good and valuable consideration received the parties hereto agree as follows:

1. Photographer will provide _____ hours Coverage, of the marriage of Client on _____ (month) _____ (day) _____ (time) of _____ (year) - the "Wedding Day".
2. Client will pay to Photographer a total price of \$ _____ plus applicable sales taxes, on the following terms:
 - a. a deposit of \$ _____ (50%) upon execution of this agreement; and
 - b. a further deposit of \$ _____ (50%) on or before _____ (date), the Wedding Day.
3. Photographer shall be the exclusive photographer for Client's wedding. (Others may be permitted to photograph only at Photographer's discretion.)
4. Photographer will use only good quality professional materials; however, Photographer does not guarantee that all colors will be reproduced with absolute accuracy in Photographer's images. Color permanency will depend on the lighting and storage of the photographs by Client, and while they will provide many years of rich color, no warranty by Photographer is implied.
5. It is expressly agreed that all rights to exclusive use and ownership, including copyright, of negatives, digitally- or electronically-produced images, or any material produced by Photographer and any reproductions there from are reserved by Photographer for Photographer's benefit, whether for display, publicity or otherwise.
6. In the event that Photographer is unable to provide Coverage, Photographer will make its best efforts to secure the services of an alternate qualified photographer; however the liability of Photographer in any event shall be limited to the refund of the deposits then paid.
7. Contracting Party hereby releases, discharges and agrees to save harmless the Photographer, its heirs, legal representatives, assigns, employees or any persons or corporations acting under permission or authority from the Photographer from and against any liability as a result of any distortion, blurring or alteration, optical illusion or use in composite form, either intentionally or otherwise, that may occur or be produced in the taking, processing or reproduction of the photographs.
8. Client may cancel this contract prior to the Wedding Day, thereby forfeiting all deposits paid, by written notice to Photographer.
